

Summary Annual Report for UA Local 190 Plumbers/Pipefitters/Service Technicians/Gas Distribution DC Plan

This is a summary of the annual report for UA Local 190 Plumbers/Pipefitters/Service Technicians/Gas Distribution DC Plan, EIN 38-3316535, Plan Number 002, for period June 1, 2004 to May 31, 2005.

The annual report has been filed with the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Plan assets, after subtracting liabilities totaled \$8,824,810 as of May 31, 2005 compared to \$6,937,613 as of June 1, 2004. During the year the plan experienced a change in its net assets of \$1,887,197. This change includes unrealized appreciation or depreciation in the value of plan assets; that is the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$2,246,254, which included employer contributions of \$284,545, employee contributions of \$1,543,984, realized gains of \$0 from the sale of assets, and \$417,725 in earnings from investments.

Plan expenses were \$359,057 These expenses included \$126,764 in administrative expenses and \$232,293 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 1,269 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

Minimum Funding Standards

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

You have the right to receive a copy of the full annual report, or any part thereof on request. The items listed below are included in that report:

1. An accountant's report;
2. Financial information and information on payments to service providers;
3. Assets held for investment; and
4. Transactions in excess of 5 percent of Plan Assets.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge. You also have the legally protected right to examine the annual report at the main office of the plan; 33035 Schoolcraft Rd., Livonia, MI. 48150 and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
